2. Disclaimer of Responsibility. I hereby acknowledge my understanding that the Heritage Guild does not assume any responsibility whatsoever for death, personal injury and/or property damage occurring in conjunction with any activity conducted on or about any of the Heritage Guild premises, including, without limitation, at 70 Hilton Street Easton, PA 18042, 50 Hilton Street Easton, PA 18042, 3321 HWY 22 East Branchburg, NJ 08876, 344 St. Georges Ave Rahway, NJ 07065 and any additional off site locations at which Heritage Guild sanctioned events are held.
3. Consideration. My Release and assumption of the obligations set forth in this Certification are given in exchange for full and adequate good and valuable consideration provided to me, including, without limitation, the use of the premises.
4. Compliance with Rules and Regulations. I have read, understand and agree to comply with all the range and/or rules and regulations posted by Heritage Guild. I expressly represent and warrant that I am not subject to any legal disability that would prohibit or otherwise restrict my right to use or bear firearms or other weapons under the laws of any state or federal authority or agency.
5. Release and Waiver of Claims. I agree and acknowledge that the use of the range facilities and/or participation in classes or instruction held by Heritage Guild is consideration for holding harmless and limiting Heritage Guild's liability. I Release and give up any and all claims that may accrue against Heritage Guild. This Release all claims, including those of which I am not aware and those not mentioned in this release. This Release applies to claims resulting from anything that might occur on Heritage Guild's premises, anything that might occur as a result of activities, or anything that might occur as a result of independent actions by Heritage Guild, and includes any claims for all personal injuries, physical pain and suffering, mental suffering, psychological injuries, emotional distress, loss of consortium, services or society, loss of wages now or in the future, and for any development, whether foreseen or unforeseen, knowable or unknowable.
6. Indemnity. I agree to indemnify and hold harmless Heritage Guild from any claim, demand, injury, or liability, whether claimed by myself or another person arising out of my use of the facilities, products or services of Heritage Guild from any claim, demand, injury or liability, whether claimed by myself or a third party asserting such claims, arising out of my use of the facilities, products or services of Heritage Guild. 7. Representation of Legal Capacity. I certify that I am not prohibited under any Federal, State or Local Law and/or by any Court Order or legal proceeding from the purchase, acquisition or possession of firearms, archery equipment, or any merchandise carried or provided by the Heritage Guild. I have read, understand and agree to abide by the range rules that I have signed and as posted by Heritage Guild; further, I agree to

abide by all verbal instruction and direction given by management and range officer personnel of Heritage Guild. I do consent by signing this certification to a criminal history search.

- 8. Acknowledgment and Assumption of Risk. I agree and acknowledge that firearms/bows are inherently dangerous and can cause bodily injury or death. I, my agents, assigns, executors or administrators, for the considerations of being allowed to enter the premises and use the facilities, firearms, bows, range, and/or other products or services of Heritage Guild, do now hereby absolutely and unequivocally assume such risks. I am fully aware that there are substantial risks to my person in the use of firearms, ammunition, bows, arrows/bolts, ranges and related products or services and that these risks include gunshot wounds, arrow/bolt wounds, caused by myself or by another, or by ricochets, inhalation of lead vapor or other poisons, and damage to my hearing from the high sound levels, or to my vision or skin from gunshot flashes and other dangers not listed herein. I do hereby accept full responsibility for my own safety. I understand that I must abide by the range rules and regulations, and wear eye and ear protection at all times that I am inside the range area. My signature and certification below confirms acceptance of this waiver of liability.
- 9. Binding Effect. The Release and obligations that I have accepted under this Certification shall be binding upon my heirs, successors and assigns.
- 10. Supervised Minors. I agree and acknowledge that "NO PERSON UNDER THE AGE OF 18 YEARS SHALL POSSESS, CARRY, FIRE OR USE A FIREARM/BOW ON HERITAGE GUILD PREMISES EXCEPT IN THE ACTUAL PRESENCE AND UNDER THE DIRECT SUPERVISION OF HIS/HER FATHER, MOTHER, OR LEGAL GUARDIAN". Heritage Guild, LLC Range Policies and Procedures

**Basic NRA Firearms Rule for Safe Gun Handling**

1. Always treat a firearm as if it is loaded.
2. Always keep your finger off the trigger and out of the trigger guard until ready to fire.
3. Always keep firearms unloaded until ready to use.
4. Always keep muzzle pointed down range.
5. Always make sure that firearms are in safe operating condition before use.
6. Always use the correct ammunition for your firearm.
7. Never use alcohol or any kind of drugs before or while shooting.

**Range Rules to Ensure Your Enjoyment of Our Facility**

1. Pistol grip shotguns are prohibited- shotguns must have a fixed full length stock.
2. Obey all commands and instructions from the Range Officer.
3. Approved eye and ear protection is required at all times in the range- no tinted/dark lenses permitted.
4. All guns must be cased or holstered when not in the shooting port.
5. Only one gun uncased or un-holstered at any time. If two people in port, only one shooter at a time. Pass gun by placing it on shooting bench, not hand to hand.
6. No loading or un-loading of firearms except on bench in shooting port.
7. Guns must be pointed down range loaded or un-loaded, actions open or closed, at all times.
8. Line of sight shooting only. No drawing from hip or holster. No trick shooting.
9. Use range approved paper targets only.
10. No rapid fire.
11. Do not shoot at anything other than targets. Anyone observed deliberately shooting at things other than their target (frames, lights, etc.) will be assessed at \$50 fee and asked to leave the range.
12. Use the help button to call the range officer for help with any jams, misfires, or other questions about your firearm.
13. No retrieval of spent cartridges or anything dropped across the firing line.
14. No eating, drinking, or smoking in the range.
15. Children 10 and over may use the range when accompanied by a parent or legal guardian. Minors under 18 must be accompanied by an adult at all times in the range and store.
16. You must be 21 years old to shoot a handgun and 18 years old to shoot a long gun without being accompanied by a parent or legal guardian.
17. Proper attire is required. No sandals or open toed shoes, no low necklines or excessively loose clothing or jewelry.
18. Range officer has the right to eject or refuse anyone access to the range. Failure to follow basic gun safety and the range rules will result in immediate expulsion and suspension of membership.
19. All ammunition is subject to inspection and approval. You must use approved ammunition ONLY. No tracers, incendiary, steel core, or armor penetrating ammunition. Shotgun shells are limited to buckshot and slug ONLY- No birdshot or target loads.
20. All firearms must arrive and leave the range in a case or holster. No uncased or un-holstered firearms may leave the port.
21. If a misfire or malfunction occurs, keep the firearm pointed downrange and signal the Range Safety Officer for assistance. DO NOT leave the firing line with a loaded or jammed firearm.
22. Instruction by Heritage Guild Staff ONLY.

\*Heritage Guild advises that pregnant women should NOT use the range.
